Student Support

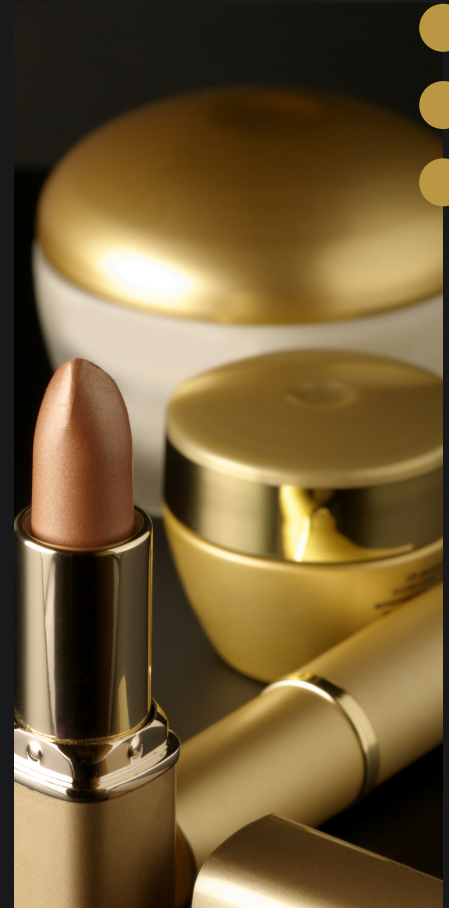
Students undertake a pre training review to determine their support needs. Students can also self-declare on their enrolment form any support requirements they may have.
